i. Operational Performance

POPLA Team Set Up

The team of POPLA assessors has changed shape significantly throughout the year. Numbers have increased and reduced with demand, and colleagues have needed to show great flexibility. Many assessors were deployed to other areas of the business as lockdown impacted the number of appeals available to work. They were then welcomed back into the POPLA team to help with high volumes after lockdown ended. Our redeployed colleagues provided excellent levels of customer service to consumers through this period.

The POPLA assessors are supported by four community coaches, a community leader, a head of operations, a regulatory manager, and the lead adjudicator.

Recovery from Adjournment

We adjourned consideration of appeals between November 2020 and March 2021 as motorists and operators weren't able to fully engage with the appeals service while locked down.

We built up a stock of over 16,000 appeals in this period, so in advance of recommencement we trained 25 new colleagues to assist with reducing the volume of appeals awaiting a decision. This activity resulted in POPLA effectively and efficiently reducing the volume of appeals, and by the end of the year we were issuing decisions well within our target Key Performance Indicators.

Calls

Between 1 October 2020 and 30 September 2021, we handled 15,819 inbound calls – answering 97% within 30 seconds and 99% within 60 seconds.

The POPLA team continues to receive calls and emails about many issues including logging appeals, requests for advice about the best way to appeal and complaints about the outcome of an appeal.

Key performance indicators

POPLA has a KPI requiring most decisions are issued within 55 days of the motorist's appeal submission. 28 days of this period is taken up by the time allowed for the operator to respond and a motorist to comment on the operator's evidence pack.

We were operating in a recovery period due to adjourning over 10,000 appeals in 2020 as a result of the national lockdown. We were making strong headway in reducing the volume of adjourned cases whilst managing all new appeals when the second national lockdown was implemented.

Our focus from October 2020, as agreed with the British Parking Association, was on placing each new appeal on hold manually and supporting motorists and parking operators throughout the adjournment period, until appeals were restarted in March 2021. The decision to adjourn for a second time expended considerable time and effort. This resulted in parking appeals being placed on hold for up to four months and impacted our KPI performance, as the time that passed from the original submission was not adjusted.

Most appeals were already in excess of the 55-day timeframe by the time we were able to resume our normal operational processes, which meant that adhering to our usual KPI was no longer possible.

We worked hard to reduce the average appeal assessment time and in September 2021 98.1% of all appeals decided were within our KPI's once more.
